**RULES & CONDITIONS OF ENTRY.**

- 1: **BY SIGNING THIS ENTRY FORM** and paying the fee, the entrant agrees to adhere to the Rules & Conditions of Entry & the GDPR Compliance Statement (below) of the Rotary Club of Amber Valley (RAV)
- 2: **THE ENTRANT CONFIRMS** to be in possession of insurance (or that of the owner if not the rider) covering their participation in this event and that it provides third party liability cover in the event of any claim for loss, damage &/or injury howsoever caused (see p.1 Rules & Conditions declaration for full details)
- 3: **EQUINE FLU VACCINATION** : To allow participation ,every rider will be required on arrival & before unloading ,to present for inspection by the organizers, a valid proof of vaccination given within the last 12 months i.e dated on or after 12 October 2019. & no later than 4 October 2020. (Please note: any proof of vaccination dated within 7 days of the event taking place is invalid) and failure to produce a valid proof document will disqualify the entrant from participation
- 4: **THE ENTRANT CONSENTS** to any photographs taken on the day by RAV &/or its representative (IndiePics Photography) being used for Rotary publicity &/or advertising purposes in connection with this event and/or future similar events organized by RAV
- 5: **RIDERS MUST** wear a hard hat with chin straps to current safety standards and suitable riding clothing which may include a body protector. NOTE :THE USE OF 'HEAD CAMS' IS STRICTLY PROHIBITED.
- 6: **RIDERS MUST** (i) wear the numbered cards issued by the Registrations Director, (ii) keep to the marked course, obey all route signs and Marshals' instructions (iii) Exercise great care at all times .
- 7: **RIDERS MUST** remember this ride is NOT a competition, race or time trial and speed is not a consideration. Reckless riders will be warned and may be asked to leave the course
- 8: **RIDERS MUST** observe the Country Code, respect riders, walkers and cyclists using the bridle paths
- 9: **RIDERS MUST** give way to traffic on all roads and observe the Highway Code
- 10: **ALL RIDERS UNDER 16 MUST BE ACCOMPANIED BY A RESPONSIBLE ADULT**
- 11: **DOGS** must be kept on a lead and under control at all times
- 12: **LEAVING THE RIDE:** Riders, for whatever reason, choosing or needing to leave the marked course and not return to the Start/Finish field, must inform the marshal nearest their departure from the course, so that the organisers know they are safe and not lost on the course !
- 13: **THE COURSE** is set out primarily on private farm land, unclassified roads and bridle paths and riders taking part in this Charity Horse Ride do so at their own risk. RAV has no control over conditions underfoot & to the extent permitted by Law , does not accept liability &/or responsibility for any loss,damage or injury to any animal, person, vehicle, trailer or other property howsoever this may be caused.
- 14: **FAILURE TO COMPLY:** Any participant failing to comply with Items 2-12 of these Rules & Conditions may be asked to leave the event.
- 15: **EVENT CANCELLATION & REFUNDS COVID-19 &/ or WEATHER** – Should the ride be cancelled because of a change in Covid-19 restrictions or bad weather, a full refund will be given. ### DIRECTIONS TO START-FINISH & PARKING

1 : All vehicles must approach the event via the A517 Belper to Ashbourne road – Please do not try & approach through Shottle village or by any other route

2: From Belper direction, take the first right after the Hanging Gate Inn on to Lamb House Lane (signed Shottle) & then follow the event signage

**Warning-** Inaccurate SATNAV directions : Please note that if your SATNAV directs you to leave the A 517 earlier at Blackbrook on to Plains lane, this is incorrect . You must ignore the instruction & continue to the Lamb House Lane turn (Direction 2 above)

3: From Ashbourne direction, take the A517 (signed Belper) Take the first left (after Cowers Lane/ Railway Inn crossroads ) on to Lamb House Lane (signed Shottle) then follow the event signage

4: All Vehicles Continue approx. 1 mile along Lamb House Lane which is a narrow single track road with passing places. Where you see signage directing you on to Hollyhouse Farm - turn right into the farm entrance . Once on the farm track, please respect the mown grass verges and follow the signs to the parking area at the rear of the farm buildings

**5: PLEASE DO NOT ATTEMPT TO PARK UNTIL INSTRUCTED TO DO SO BY MARSHALS**

### DEPARTURE ROUTE

1: **EXIT ROUTE** : You will NOT be able to leave the site via the main farm drive used on arrival. Instead, turn left on to the track at the bottom of the car park (follow arrows) - Continue approx 400 metres to farm gate exit then turn right on to unclassified single track road (Plains Lane). Continue approx 2 kms. into Blackbrook village & rejoin the A 517. ( Turn left for Belper & right for Ashbourne)

**2: WARNING TO EARLY LEAVERS** : This exit route from the farm will still be in use by approaching riders finishing the course so please do NOT attempt to leave without marshal supervision.
